Andy Catton (Ilford AC) has contacted County to express his concern that a number of the Championship road races are getting sold out quickly which is potentially preventing some runners, who may be in contention for County medals, not being able to enter. Brigid Wallen reported that the Cross Country relays held at Stubbers, Upminster, went well. 246 entries were received (up 27% on the previous year). Only four teams did not turn up on the day. It was a return to this venue after a number of years (although it has been used by Essex schools). Areas for improvement were identified (time – keeping, lack of funnels, the course was slightly short and change over areas for the Senior race) if the event is held there next year.

If the event continues to grow then parking may well be a problem at this venue.

Gerry O'Doherty suggested that in all future XC championship events, Chip Timing should be used. This will be discussed at the next Endurance committee meeting.

Richard Casey advised the meeting that the Schools Cross Country Championships will be held at Hylands Park on the 20<sup>th</sup> January. Ron Dawson asked Richard Casey to let him know how much Hylands were charging to host the event.

## 9) Road Running

The County 10 mile race championships are being held at Stebbing on Sunday 12<sup>th</sup> November. The race has sold out.

At the Billericay Striders 10k held on the 5<sup>th</sup> November, there was another incidence of a competitor passing their number to another person without informing the Race Director. This nearly resulted in a trophy being awarded to the wrong individual. At a recent County meeting it had been agreed that should this happen in the future at a County event, both runners would be disqualified from all Essex Championship events for a period of 12 months.

Gary Chandler reported that we still do not have a venue for next year's 5 mile championships. He has contacted Braintree AC and is awaiting a response. The Saffron Striders fast 5 is another option but it was held for the first time this year and the club would like another year of organising the race before they agreed to hold the County Championships.

#### 14) AGM

**15**) **Any other business** Allison Gillian advised the meeting that her husband is working on the production of the next Essex AA promotional video. It will include clips about Coaching, Officials and Course Measuring.

Gary Chandler and Dave Staines had received an email from Woodford Green AC & Essex Ladies ("Woodford Green") in connection with the acquisition of the Photofinish equipment. County are contributing £7,000 towards the purchase. The monies are provided as an advance payment on rentals, in return for 24 uses of the equipment. Woodford Green suggested terms were slightly different to that

that was agreed in the October meeting and so Gary was seeking confirmation from the committee that he could still proceed. The terms will be "This hire agreement is for 24 single day hire events over the period 2018 through to 2023. In the event that Woodford Green cannot provide system for a requested day then those days can be added to the end of this period - e.g. 2024 onwards at the rate of 4 events per annum".
